# Message from Chief Crystal Okemow

## Tansi Lucky Man Cree Nation Members,

I hope this reaches you in good health. I'd like to take this time to acknowledge our relatives who have went on ahead to the other side. My heart and prayers go out to the families, partners/spouses, friends and to the nation. A loss of a relative in Lucky Man is felt by each of us. You are not alone. We must keep each other in prayer and uplift one another with good thoughts and energy. Life is tough sometimes but we must be reminded that the Creator looks out for us even when we don't understand. Ceremony helps, whether your ceremony is our nehiyow way or church or maybe it's both, keep your faith, continue to pray.

There has been lots going on for Lucky Man. The following has been the focus:

## Restructuring/Reorganization of the Band Office/Administration

Bonnie Evans Whiteford has been the lead in this area. Takes a lot of time and focus to do this, getting information from Indigenous Services Canada (ISC), organizing weekly staff meetings, implementation of policy, meeting with LMCN project consultants and managers, following up with auditor, etc. Bonnie and staff have been working on getting all outstanding reports up to date. Working as well on getting Lucky Man up to date in terms of audits. The 2021-2022 audit has been submitted. Work on the 2022-2023 audit is underway and should be submitted by the end of December 2025. Lucky Man will be caught up with the audits by summer 2026. I have requested a forensic audit to ISC, it would be ideal if ISC covers the cost of the forensic audit as they can be expensive. A formal follow up will happen when all audits are caught up as that is what's required to do a forensic audit. A good step in accountability and transparency and also a good start on a clean slate moving forward.

# Roads/Cultura Renovation & Gazebo/Ceremonial Building

Request for proposals (RFP) will be sent out in the new year. Construction will start in spring 2026 on these projects. The one mile road construction will be funded by ISC. The cultural renovation and gazebo is the hall renovation and will be funded by the Canadian Human Rights Tribunal 41 (CHRT41). Ceremonial building funded by other source.

## Second Net Zero Home (High Efficient Home)

Piling foundation has been done. Cistern and septic for this home has been installed. The home is being built off site and will be moved to Lucky Man in spring 2026. This home will be in the cultural area and will house Lucky Man's knowledge keeper. The home is funded by ISC Immediate Needs.

#### Lucky Man Water Truck

Lucky Man was in need of a water truck that could deliver water but also provide some fire protection. Lucky Man purchased a Ford Super Duty 750. This truck was funded by Lucky Man interest revenue that also provides biannual per capita distributions. The truck is presently being built and pick up date is scheduled for December 15<sup>th</sup>, 2025.

#### SaskPower

Discussions with SaskPower have been happening for the past while regarding 3-phase power. With the upcoming projects for the renovation and ceremonial building, Lucky Man is maxed out on power with just power boxes being there. In order to bring more houses, other buildings, water treatment plant, basically anything that needs power, LMCN needs 3-phase like towns and cities. This will take approximately a year to get the 3-phase power to the rez. Leadership, SaskPower and Urban Systems is meeting with Mayfair council on December 11<sup>th</sup>, 2025, for a meet & greet and to provide information on the 3-phase power plan. SaskPower will need to go to the farmers doors to get permission to build or put up poles so the meeting will be a preempt to that door knocking that SaskPower needs to do. The \$1.8M cost will have to be covered by ISC.

## **Specific Claims**

There was a specific claims tribunal court date set for November 27<sup>th</sup> & 28<sup>th</sup>, 2024 but has been changed to an evidence hearing now. The judge for the specific claim has challenged the evidence that both Canada and Lucky Man has presented. As stated by our legal counsel, this is the first time this has happened in any of the claims he's been involved in but has assured us that it does not change the claim or its strength however it does add time to the process, a few months.

## Lucky Man Pasture

Pasture patrons will be reduced to two patrons starting in 2027. The land needs to recover from it being a pasture for 30 years. The hope is to have medicines return and also have more access to the lands without all the fences.

# Other/Ongoing Projects

Conversations with Canada (RIRSD) table. This is still ongoing. C-92 funding ended by May 2025. The C-92 coordinator (Fonda) reapplied for funding in late October, early November and is awaiting a response. Battle River Indigenous Relations Council (BRIRC) is still providing project management for the ongoing reserve projects. The staff are Alan Alex (PMP, MASc. BEng.), Director of Crown Consultation and Thona Longneck, Executive Director.

We've started quarterly meetings (every 3 months) with the Regional Director General of ISC which is Rob Harvey, Saskatchewan region. These meetings are important as this is

where we bring up policy funding issues and challenges but this is also a place to discuss opportunities for Lucky Man.

# **Councillor Terrence Okemow: Portfolio Report**

Tansi Lucky Man Cree Nation, I hope this letter finds you in good health. I am excited to share the latest news of the projects that the nation has being working on. Lucky Man Cree Nation is evolving with big changes on-site and in office. As we all know that the First Net Zero Home is complete and with a little bit of ironing out, things are working out a lot smoother and up to specs. I'm still monitoring the energy usage and savings with the houses solar panel usage. One of the unforeseen planning was a cistern tank being added and the water that needed to be hauled in. We can haul our own water December 15 when the truck is delivered on our nation.

On that note, LMCN needs a 3-phase powerline to add more infrastructure and residential homes, streetlights next to our new road that commence construction in the spring of 2026. This negotiation was with ISC and our community designer/engineers of Urban Systems. New powerlines and replacing old lines that was in place since the 1950's will benefit not only the community but the surrounding neighbors.

Back to home building, another home is being built in a Net Zero style but in RTM (ready to move), equipped with unique advancement for a combination of high energy efficiency and on-site renewable energy generation. 80% more efficient that the average new homes which minimize energy needs for heating and cooling and ultimately lowering utility bills, provide a more comfortable and healthier indoor environment, reducing carbon emissions. This home is being build by Voce Developments outside of Saskatoon and will be placed on piles just like the previous Net Zero Home. These piles were drilled and completed October 2025.

The nation was also testing for water, Beckie Hydrogeologists prepared analysis that was pulled from Andrews and Sons Drilling both from Regina. A total of 8 drill holes were tested in various locations on the land. Beckie confirms that the quality of the water is acceptable for the nations potable water needs.

I am hoping to see you at our Lucky Man Cree Nation Christmas Meal, safe travels, stay warm and be safe. Hiy hiy!
